Ashley Dimkich went on to receive the title of TCUSD's district Teacher of the Year, and moved on to the LA County competition, and was recently named one of 16 LA County Teachers of the Year! Shelley sat down with Ashley to ask her about the process:

#### What / Where and How long have you been teaching?

I'm just beginning my 10th year! I've taught all ten years in TCUSD at Emperor! Go EAGLES! I taught 3rd grade my first year and have been in 4th grade ever since! :)

#### What was the process after becoming an LA County Teacher of the Year?

The Los Angeles County Teacher of the Year Application process was quite lengthy and took place over the summer, but it was also such a fun and memorable experience! We had to submit a number of essays, lesson plans, a recorded video, and other materials to LACOE. The process followed a VERY strict format and so much as one word beyond the word count limit on an essay would have been cause to be eliminated from the competition! The judging panel narrowed the field of the 66 district-level teachers of the year who participated in the competition down to a semifinalist group of 28. We then completed a round of panel interviews where we were asked to expand on our philosophy, demonstrate a lesson, and more! Then, on September 23rd, all district-level teachers of the year were honored at a beautiful Awards Banquet at the Universal City Hilton. This is also where the top 16 LA County Teachers of the Year were named, I was so honored to represent Emperor and TCUSD as my name was called!

#### What's next?

All 16 Los Angeles County Teachers of the Year now advance to the California Teachers of the Year competition this fall. The competitors are made up of the teachers from across the state. We already had to submit our written application to the state, and from there they will be notifying a group of semifinalists. Those semifinalists would have a classroom observation and from there the judging panel would select a group of finalists who would advance to another round of interviews including one with our state superintendent, Tony Thurmond! After that, 5 California Teachers of the Year would be named and one would advance to the National Teacher of the Year Competition representing the state of California.

Congratulations to Ashley on this huge honor! We are so proud and rooting for you as you move to the California State competition!

# Barganing (polate

With the new superintendent starting in just a couple of weeks, the TCEA negotiations team is eagerly anticipating the start of negotiations. Since Dr. Cuhna is slated to start on November 1st the district has decided to hold on submitting items to sunshine so that our new super has input on the direction TCUSD goes.

We are looking to expedite our negotiations this year and hope to be concluded with the majority of the items before we head off to winter break. With this in mind, the TCEA executive board met this week to discuss what 3 items we would like to sunshine for this round of negotiations. These items will be presented to Dr. Cunha within a couple weeks of his start date. Additionally, the TCEA negotiations team has started meeting regularly with our CTA representative to determine roles in negotiations and what each member's strengths are and what they would like to contribute in addition to looking at state COLA's, comparable districts, and expanding our strategy with current TCUSD administration.

This year, we are looking deep into our Special Education and retention issues and trying to find meaningful ways to address our member concerns. Finding the ideal place in our contract to add language has become the biggest challenge to the team so far. The district and previous years negotiations teams have all agreed that this is something that needs to be addressed as soon as possible, finding how to add it has slowed the process though.

Finally, a small stipend committee has formed to work with district personnel to look at all of our stipends and the level in which they are paid out. There are a handful of stipends that do not apply or are no longer used- illuminating those will open up funding for other stipends that have presented themselves and become more relevant with the services we provide to our students. Once work is complete on the updated list of stipends, the TCEA negotiations team will present them for approval during bargaining.

Bargaining Unit comparable districts: Historically TCEA has used the following 6 districts as "comparable" districts when negotiating. These districts are considered comparable to Temple City because they all uphold high academic standards, are unified districts of similar size, and are located within the San Gabriel Valley. The districts are Arcadia, Claremont, Glendora, La Canada, San Marino, and South Pasadena.

Recently San Marino closed their negotiations for the 22/23 school year. They bargained for 5% off salary schedule (one-time bonus), a 7% on schedule salary increase but also INCREASED their work year by 3 days. Each day of work is .54% of a 1% salary increase. This means that due to working 3 more days, the 7% salary increase is actually only a 5.38% salary increase.

It appears that Glendora has settled negotiations for this year (22/23) and next year (23/24). They negotiated for 1% off schedule (one-time bonus) and 5% on the salary schedule for 22/23. For the 23/24 year they will have a 2% salary increase added to the salary schedule.

#### Vote Initiative



Yes


