

Welcome Back! The beginning of the school year has always been a time for me to be mindful of the past, present, and future. I look to the past and evaluate the last school year in hopes of having a better year. I feel the present is looking very bright for TCEA and there are many wonderful possibilities for the future.

Paying our monthly union dues provides membership not only in TCEA, but also CTA and NEA. The benefits of membership are vast, and some of the most valuable features of membership are the tools we can use when planning for the future or for an unexpected event. To help plan a less stressful and hopefully fabulous future here are a few bits of useful information:

As California state teachers, we do **NOT** pay into state disability insurance which leaves us bare in the event we have a covered illness, injury or pregnancy. However, as union members, we all have access to the CTA sponsored disability insurance company: The Standard. Please, spend some time investigating their services. Josh Hayes, our representative, will be at the Back To School Breakfast and can be contacted at any time to enroll new members. in disability and life insurance at josh.hayes@standard.com. American Fidelity is **NOT** sponsored by our California teachers' association.

As a member of TCEA, strongly consider donating two of your personal days to OUR Catastrophic Leave Bank (CLB) so that in a time of need you have opportunities and options. Look for the form in your box within the next few weeks, or call payroll and join at any time. It takes only 30 days to be vested in our CLB.

Financial professionals advise planning for retirement as early as possible and CTA can help with saving and investing. CTA's 403b plan (pre-tax investing) which has the teachers' best interests in mind, is a nonprofit plan with the most minimal fees. This means MORE money is invested. TCEA is sponsoring a CTA 403b member benefit event on Monday, OCT 7th at TCHS, at 3:30 pm. Join us!

Consider planning for retirement now by saving your personal days. There is tremendous value in the ten personal days we receive each year. Our unused personal days count toward our years of service to the district. About 92.5 personal days add up to 50% of a year and 185 saved days is an additional work YEAR which counts as a year of service toward your retirement with CalSTRS. You do the math!

TCEA's contract has been in development since 1967 and thanks to past negotiators it's a strong contract that affords us all excellent working conditions. Due to our current team of dedicated negotiators we are currently in successful contract negotiations with the district's negotiators and I'm grateful that the two teams holds one another in mutual respect. TCEA continues to look toward strengthening our language to improve your working conditions well as bringing our salary and benefits in line with comparative districts. Be assured that TCEA negotiates from member survey results and will provide members with a survey to their personal email when needed. Please give your personal email to your building representative to ensure your voice will be heard.

TCEA Grant Recipient Write-up

My name is Jamie Campbell and I teach SPED Math at Oak for both 7th and 8th graders. My students have different needs and abilities and so my approach in teaching them has to include various methods and lots of differentiation.

I learned many valuable ideas attending the CUE Conference this past March. One important resource I received was "Design Thinking"- a creative approach to problem solving. My students struggle with solving problems that involve stories because many of them have difficulty with reading comprehension. It's always been hard for me to be patient because my students can spend lots of time just staring at a problem and wait until they're given the answer. Instead of giving them a bunch of problems to solve. I give one at a time and wait for everyone to come up with a solution. Then we discuss how they came up with the answer and if their solution answered the question. We talk about where they may have misunderstood the problem. We also talked about different strategies that they used to come up with their answers. Through that, they learned that there are different ways to solve a problem and they are able to find ways that make sense for them to approach a problem. This has really helped me and my students in creative thinking and problem solving.

Another valuable resource I encountered was Equatio-which helps students, especially those with math struggles, see it more visually. For students with dysgraphia, the program helps them to digitally illustrate math concepts.

Technology is an integral part of learning for my students with special needs. Showing them how to use resources to overcome their struggles will help them to be more successful in accessing the curriculum and learn the concepts necessary to complete the courses. They are also learning important skills to be successful in life.

I really appreciate the opportunity to have attended this conference. This was the first time I was able to attend and if not for TCEA, I would not have been able to go. Thank you so much for your support.
